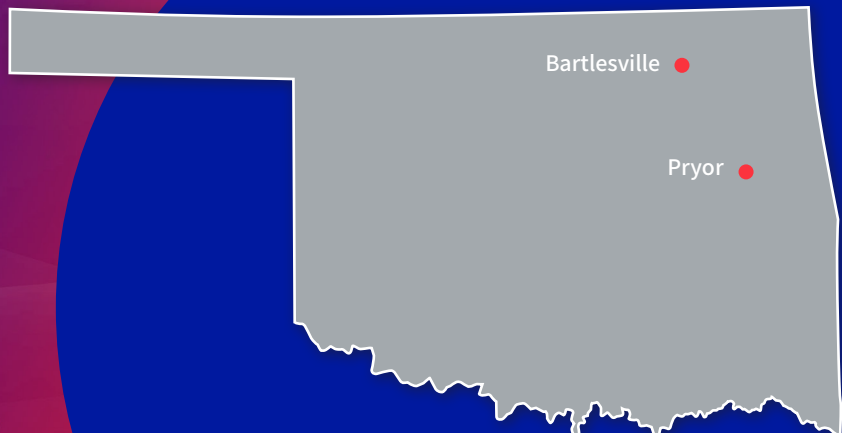
On Jan. 8, 2023, CPChem and QatarEnergy announced plans for a \$6 billion polymers complex in Qatar's Ras Laffan Industrial City, featuring the Middle East's largest ethane cracker and two high-density polyethylene

derivative units.

Additionally, CPChem and QatarEnergy initiated construction on the Golden Triangle Polymers Company in Texas on March 7, 2023, a joint venture focused on ethylene and polyethylene production. Most recently, on Aug. 3, 2023, CPChem celebrated the opening of its second U.S. 1-hexene unit in Texas, employing advanced technology to produce high-purity comonomer grade 1-hexene from ethylene.

## Products

Bartlesville Research and Technology Center (BRTC) is located 1 mile west of downtown Bartlesville and is part of the Phillips 66 Research Center, a 440-acre campus. As part of the PRC, we maintain a close working relationship with Phillips 66, and they provide many services for BRTC. In 2000, the Pryor plant became part of Performance Pipe, a division of CPCChem. These facilities are major employers in the area and make contributions to local tax revenue.

Employees at the Bartlesville facility focus on the research and development of new chemicals and plastics and work to improve existing chemicals and processes. They also provide hands-on technical support for customers around the globe. The facility supports the global polyethylene, normal alpha olefins, drilling specialties and specialty chemicals product lines. Products produced at the Pryor facility include high and medium density polyethylene DriscoPlex®.
